



## EEP S&EA funding

The EEP S&EA Programme is funded by the Ministry of Foreign Affairs of Finland (lead donor), UK Department for International Development (DFID) and the Austrian Development Agency (ADA). The Partnership focuses on projects in all fields of renewable energy, bridging the gap between a good idea and a bankable project by providing part-financing to project proposals. These projects include various types of feasibility studies aiming at concrete investments, as well as pilot, scale-up and demonstration projects.

Total funding for the first phase (2010-2013) was 25 million Euros and second phase (2013-2017) 35 million Euros.

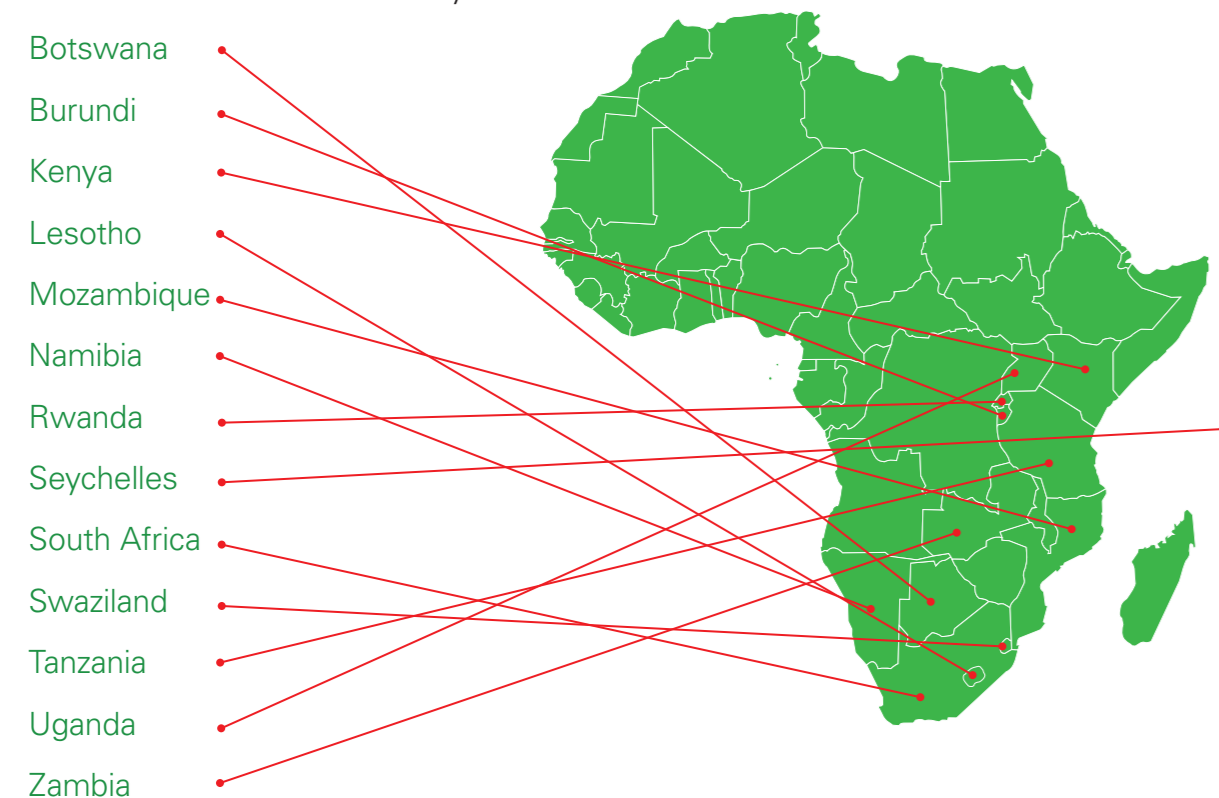


## About the Programme

The Energy and Environment Partnership Programme of Southern and East Africa (EEP S&EA) has been running since April 2010 and is currently supporting thirteen Southern and East African countries. The overall objective of the EEP-S&EA is to reduce poverty by promoting inclusive and job-creating green economy and by improving energy security in the Southern and East Africa regions while mitigating global climate change.

## Energy sectors

EEP grant supports renewable energy and energy efficiency projects in all renewable energy sectors, including biomass, biogas, solar PV, wind power, waste-to-energy, hydro and hybrid etc.



## Two funding windows

EEP S&EA Programme has two funding windows.

### Window 1: Inclusive innovation

For projects at an early stage of implementation, including pre-feasibility, feasibility, demonstrations and small pilot projects.

### Window 2: Renewable energy and energy efficiency market creation

For projects that are near-commercial private sector projects, with a greater grant size and leverage expectations.



## Project Beneficiaries

The EEP S&EA projects are implemented by different types of organizations including private sector, public sector and government institutions, CSOs, NGOs, FBOs and research institutions. The final beneficiaries of the Programme include households, communities, health service centers, schools, small and medium enterprises (SMEs) and industries that have access to improved energy services from EEP supported projects. Energy services from these projects contribute to creation of income generating opportunities, quality of social services, communication and the quality of life in general.

## Programme Organization and Governance

The EEP Phase II management and implementation is coordinated by the KPMG Finland EEP Coordination Office (KPMG ECO) based in Pretoria, South Africa. In the participating countries National Coordinators are appointed from the Ministries of Energy to participate in Programme coordination at the country level, providing also insights of new energy innovations in a region. Representatives from the donors, the Southern Africa Development Community (SADC) and the East African Community (EAC) are members of the Supervisory Board, which has the overall oversight of the Programme.
